**NOTIFICATION**

The following Survey Fees are prescribed Under Rule-9 of the Goa, Daman and Diu Land Revenue (Boundaries and Boundary Marks) Rules, 1969 for demarcation of Survey Number or Sub-Division boundaries, and Rules-17 of the Goa, Daman and Diu Land Revenue (Revenue Surveys and Sub-Division of Survey Numbers) Rules, 1969 as fees to be recovered for making Sub-Division, in case to which clause (b) of Section-101 of the Goa, Daman and Diu Land Revenue Code, 1968 applies.

AND

As per Section 66 of the Goa, Daman and Diu Land Revenue Code, 1968 read with Rule 8 of the Goa, Daman and Diu Land Revenue (City Survey) Rules, 1969 provides for the fixing of Survey Fees by the Collector. As per Government Order No. RD/SRV/448/68 dated 16.07.1970 had Ordered for carrying out Survey Under Section 65 of the said Code.

I, now therefore, fix the Survey Fees as mentioned below for U. T. of Daman & Diu.


